

INFORSE-Europe participated at **UNFCCC COP28 in Dubai, UAE** with two side events and one week exhibition organized in cooperation with other members from Europe and other regions.

FULFILL project continued



INFORSE-Europe's participation in the **FULFILL Project** continues. We gathered data on sustainable lifestyles characterized by the use of fewer resources in daily life. In this context, we and our project partners conducted interviews, online surveys and created workshops with citizen-driven initiatives from all over Denmark to learn about the results of these initiatives. In the project, we also analysed local initiatives for sufficiency including volunteer repair shops, car

sharing clubs, cloth sharing shops, eco-villages. Further we analysed policies for more sustainable lifestyles including policies for bicycle paths, more plant-based food, and tiny houses.

As a part of the FULFILL project, we also co-organised an international citizens-science workshop (November 2023) at the Jacques Delors Institute in Paris, France. The workshop brought together citizens from 5 countries (including 5 persons from Denmark) where citizens discussed the sufficiency they wanted. INFORSE-Europe also participated in a project meeting and an expert meeting in Berlin in March 2024.

The FULFILL project is supported by **EU Horizon 2929 Program.** The partners are: Fraunhofer ISI (lead) and Wuppertal Institute in Germany; Negawatt and Jacques Delors Institute in France, Eurac research and Politecnico Milan in Italy, Green Liberty in Latvia, and INFORSE-Europe in Denmark.

Information and debate about the EU in Denmark





In Denmark, INFORSE-Europe organized several debates and information activities on EU and sustainable energy together with the Danish INFORSE members. The activities were funded by a 3-year grant from Europa-Nævnet, which is a fund for information and debate on EU in Denmark in 2021-2023.

On June 18, 2023, INFORSE-Europe participated at the annual *People's Political Festival (Folkemødet)* on the island of Bornholm, where we organized a debate on the efforts and capabilities of the EU concerning sustainable consumption. In this context, our event included a debate with member of the European Parliament Niels Fuglsang (Social democrats) and active chair of the Danish SustainableEnergy, Kathrine Olldag.

In addition to this event, INFORSE-Europe organized local events on **EU, climate and energy in 8 Danish towns,** in Copenhagen/Sundbyvester, Aarhus, Samsø, Hårlev, Roskilde, Esbjerg (energy people's meeting), Mørke, Høje Tåstrup.

To increase the knowledge on EU and climate and energy a **32-page publication "EU and the Green Transition"** was made in Danish. Each topics is covered in about 2 pages, and the respective pages can be used for relevant events.

Better Green Deal - Nordic-Baltic, Belarus and Ukraine Project



INFORSE-Europe is working with CSOs on a joint project on Better Green Deal with CSO policy proposals, visions and scenarios for best mitigation policies for Nordic-Baltic Sea Countries, Belarus and Ukraine.

The partners of the NGO cooperation Project are INFORSE-Europe (coordinator), and INFORSE-Europe members: Norges Naturvernforbundet, Circular Economy in Lithuania, Latvian Green Movement, Ekokoncepcija in Lithuania representing civil society - Ecodome NGO in Belarus, Ecoaction in Ukraine, and AirClim in Sweden.

The project is funded by the Nordic Council of Ministers, Airclim and INFORSE-Europe.

European Policies



Ecodesign and Standards for cleaner heating

INFORSE-Europe staff worked with the European Environmental Coalition on Standards and the Coolproducts Campaign on EU ecodesign regulation, EU product energy labelling, and European standards to have higher efficiency and cleaner combustion of boilers and room heater, including wood stoves that have large potentials to become cleaner.

Phase out Fossil Heating

INFORSE-Europe staff and members worked with European Environmental Bureau and the Coolproducts Campaign on an analysis of what subsidies are needed to change all European gas and oil heating to renewable energy with heat pumps and solar heating. This was presented in a webinar in September 2023 and in the report "Green Heat for All 2 – A re view of necessity and feasibility of a just and green heat transition"



European Sustainable Energy Week

In June 2023, INFORSE-Europe participated with an exhibition at the **European Sustainable Energy Week**, dedicated to renewables and efficient energy use, as well as sufficiency, presenting activities of network activities and policies.



Cooperation with other INFORSE-regions



The INFORSE-Europe's Secretariat finished the 4th phase of the INFORSE cooperation project on Eco Village Development in South Asia.

The projects is led by DIB (Denmark) and now runs until end of 2023. The South Asian partners are: INFORSE South Asia members, and national focal points: INSEDA (India), IDEA (Sri Lanka), CRT (Nepal), Grameen Shakti in Bangladesh and CANSA. The final Project assessment was published and launched in December 2023.




