

# **The position of Polish NGOs in March 2022**

## **EU funds must fund green national energy security!**

Putin's aggression against Ukraine has overturned priorities in a Europe dependent on Russian fuels.

To break this dependence, the European Union must accelerate its green transformation.

It is necessary and urgent to review the priorities of spending EU funds.

The Polish dependence on Russia is huge - in 2020, we bought about 66% of our imported oil and 55% of our gas from Moscow.

NGOs and experts support the declarations of the Polish government and the European Commission to move away from gas, coal and oil financing the Kremlin's oppressive regime and call for turning declarations into actions.

There is no general consensus on how to replace Russian fuels.

In the public debate there are false solutions, such as "coal rehabilitation", which are economically unjustified and will **not ensure the country's energy security**, but will instead **deepen the climate crisis**.

The only solution is rapid and large, yet **thoughtful, systemic investments** in energy efficiency (electrification of district heating, thermal modernization of buildings), **renewable energy sources** (except for solid fuel combustion) and **decarbonization** of industry.

These are the priorities set by the European Commission in the EU REPower initiative related to the war in Ukraine, which aims to reduce gas imports from Russia by  $\frac{2}{3}$  by the end of 2022 and to phase it out completely by 2030.

**The Polish legislative base needs immediate improvement as it hampers the development of RES in Poland instead of stimulating it.**

The resources to ensure green energy security are there.

**They just need to be spent properly.**

Poland can count on hundreds of billions of euros from various EU financial instruments:

EUR 76 billion under the Cohesion Policy,

EUR 58 billion under the National Reconstruction Plan

EUR 9 billion from the Modernization Fund

In the case of the Cohesion Policy and NRP between 30% and 37% of the funds must be spent on climate action, and in the case of the Modernization Fund, all of it.

Poland's priority must be to save energy and replace fossil fuels with renewable energy sources.

The new energy doctrine of green energy security, based on local resources of green energy, must be!

## **Priority must therefore be given to:**

- Investment in energy saving and energy efficiency
- Increase investment in clean air measures rewarding energy efficiency and RES-based solution, withdraw from the policy of "gasification of the country".

- Increasing investment in clean transportation, including the development of multimodal transportation solutions, which include rail.
- Supporting the development of green urban transport, including streetcar, bicycle and pedestrian infrastructure.
- Thoughtful and systematic investments in renewable energy sources: modernization of distribution networks and creation of energy storage facilities.

At present, the European Funds for Infrastructure, Climate, Environment (FEnIKS) programme provides only €599 million for investments in RES - 10 times less than for roads and natural gas

- **Unlock and support the potential of society through increased funding for all forms of prosumerism, including energy communities.**
- Decarbonizing industry, i.e. supporting industry to reduce the need for imported fuels.

**EU funds must support the country's green transformation and energy security.**

Hundreds of billions of euros must not be wasted!

We call on the Polish government and the European Commission to urgently work on appropriate changes to the EU structural funds.

The position has been sent to the government and the European Commission.
